Relocation of Cold Storage Facility

Enterprise iLembe invites quotations from experienced, suitably qualified, service provider for the relocation of a Cold Storage Facility from Hlomendlini to Nyoni (Ndulinde) area as specified below:

- Disassembling of the cold storage (panels)
- Build 22m x 7m x 500mm concrete slab with water drainage
- Assembling of cold storage panels to new site
- Uninstall and install condensing unit
- Uninstall and install cold room air cooler unit
- Cold storage electrification
- Install and connect power cable from power supply to cold storage
- Install 3 phase distribution board
- Transport of panels, air cooler unit and condensing unit from Hlomendlini to Nyoni.

Please note that a compulsory site briefing will be held on 26 January 2022 at 11h00 in Hlomendlini, coordinates (GPS: S 29°10'28.5" E 31°23'55.5")

Quotations must be accompanied by the following documents:

- Valid TCS Pin number issued by SARS (compulsory)
- Proof of registration on the Central Suppliers Database (compulsory). (The registration number/report will be available on the CSD Website once you have registered)
- Proof of residence in iLembe (i.e., a Utility Bill, Signed Lease Agreement or Original signed Councilor Letter from any of the following regions viz. KwaDukuza, Mandeni, Maphumulo or Ndwedwe) (compulsory)
- B-BBEE Status Level Certificate (if you have)
- MBD 4 – Declaration of Interest Form (compulsory)
- Company registration documents (compulsory)
- Proof banking details/ Bank Statement (compulsory)
- Certified copies of Qualifications of Electrician (compulsory)
- A minimum of two (2) signed reference letters for the business for similar work undertaken (assembly of cold storage facilities and/ or electrical work) (compulsory).

All proposals will be evaluated and adjudicated in terms of the approved Supply Chain Management Policy of Enterprise iLembe on the 80/20 Preferential Procurement points system read together with the 2017 Preferential Procurement Regulations.
