#### Prequalifying Criteria:

In line with the 2017 Preferential Procurement regulations, Enterprise iLembe has decided to apply pre-qualifying conditions to advance certain designated groups within the iLembe region; i.e service providers must be located within iLembe with a minimum B-BBEE status level of 3. The purpose of this is to enable the advancement of previously disadvantaged groups within the region thereby stimulating the local economy.
